Registration

The registration fee, family fee and testing fee are non-refundable. At the time of re-registration, all tuition, fees, and service hour commitments must be current in order to re-register. Families who are not current in tuition, fees, and service hour commitments must bring their accounts up-to-date before receiving a re-registration packet. The placement of a student in a class cannot be guaranteed if the family account is not up-to-date at the time of re-registration. In the event of a waiting list, the family with the delinquent account will lose its preferred position, and the next family on the waiting list will replace them.

Family Fee

Each family is required to pay the sum of \$650.00 per school year for the Family Fee. Full payment must be made by July 1st.

Service Hours

Every family is expected to donate and provide no less than forty (40) hours (twenty [20] for single parent families and pre-school only families) of service to the school during each school year that a child is enrolled. Half of the hours must be completed by December 31st and the balance is to be completed by May 15th. Parents may opt to satisfy the service hour requirement by the payment of \$600.00 (\$300 for single parent and pre-school only families.) However, if a family is receiving any form of tuition aid or assistance from the school or St. Cecilia Parish, payment in lieu of service hours is not allowed. If all such service hours are not provided to the school, the parent(s) will be billed by the school. The rate for each un-worked service hour is \$15.00.

Service hours must be completed and logged in the Service Hour Logbook located in the Front Office by the deadlines of **December 31** and **May 15**. Parents will be billed for any un-worked/unlogged hours after those dates. Parents are responsible for logging their own hours in the Service Logbook. The school cannot accept telephone calls for the recording of hours.

Pastoral Assistance Surcharge

St. Cecilia School families are assessed a surcharge, which is a percentage of the difference between tuition charged and the actual cost to educate a student.

The Pastor of St. Cecilia Parish has agreed to pay the surcharge for families who are registered, active, and supporting parishioners at St. Cecilia Church. An active and supporting parishioner is defined as someone who participates in the weekly Sunday liturgy and who uses the Sunday envelope on a regular basis, thereby contributing to the financial support of the parish. Financially supporting is defined as \$300 per calendar year. A minimum of \$150 is payable from January 1-June 30 with the second minimum of \$150 payable from July 1-December 31. If the financial support is not met for either calendar period, then a charge of \$38 per month, per child, will apply for the following five months. During those five months, in addition to the surcharge, the family must contribute the minimum of \$150 in order to have the surcharge removed for the subsequent six months.

Non-parishioners are responsible for the \$38.00 surcharge and will be billed monthly for it. Additionally, the pastors of these students will be asked to pay the family surcharge for their parishioners. If the school receives the payment from the pastor, the family account will be credited. If the pastor chooses not to make the payment, then the family is responsible for it.

Auction Gift

A donation of a new and unused item for our annual **Auction** is mandatory. Such items must be valued at a minimum of \$75.00 and are due by October 1, 2010.
